

# Glossary of Key Terms

Actual Cartons (ActCtn)

• Number of cartons that are on a pallet as provided by data source. (The number cartons can differ depending on the pack type code e.g. J60B has 2 cartons, and A15C has 80 cartons)

# **Country of Origin**

• Reports are based on South African exports only. The country of origin code in the data source is ZA.

## Equivalent Cartons (EqvCtns)

- The net mass provided by the data source, divided by the standard mass as per commodity.
- Nett mass is validated to be within certain tolerance based on pack type codes. e.g. Grapes standard mass is 4.5 kg where the Oranges are 15kg and Grapefruit is at 17kg

### Pallet Quantity (Plt\_Qty)

• The Pallet Quantity provided by data source. No distinction is made between pallet types

# Glossary of Key Terms

# **Shipped Date**

- Shipped date is the sail date from the Port of Loading for the vessel.
- Pomefruit & Stonefruit Shipped Date / Export Week is the date of the last South African port of loading
- (Initially the shipped date is received from the data source. The vessel sail date is updated according to Marine traffic and Transnet to use the actual shipped dates)

### Shipped\_week

- The week of the year, starting on a Monday, derived from the shipped date.
- Pome and Stone fruit use Shipped\_week\_za in this field.

### Shipped\_week\_pol

• The week of the year, starting on a Monday, derived from the shipped date when the vessel left the port.

#### Shipped\_week\_za

• The week of the year, starting on a Monday, derived from the shipped date when the vessel left the last South African POL. (NOT the port the container was loaded in)

### Year To Date (YTD)

• Year To Date (YTD) Data for the current season. The season dates are managed on commodity level.
