TRANSNET PORT TERMINALS (TPT) CUSTOMER ADVISORY: NOTIFICATION OF PROTECTED NATIONAL PROTEST ACTION BY COSATU – 19 JUNE 2026

Transnet Port Terminals (TPT) would like to inform stakeholders of a potential disruption to transport and logistics operations arising from a Congress of South African Trade Unions (COSATU) nationwide socio-economic protest scheduled for Friday, 19 June 2026.

It is anticipated that port access roads and logistics movements may be impacted, particularly impacting landside operations across terminals. TPT has proactively activated its national operational readiness, and business continuity plans to ensure a coordinated and effective response to any disruption that may affect terminal operations. This includes close coordination with relevant authorities such as the South African Police Service (SAPS), Transnet National Ports Authority (TNPA), and other security stakeholders.

At this stage, waterside operations across TPT terminals are expected to continue as planned. However, landside operations may experience significant delays due to potential access constraints and congestion in affected areas. TPT will continue to monitor developments closely and will provide timely and proactive communication should there be any changes impacting operations.

The safety and well-being of our employees, customers, and stakeholders remain our highest priority. While we anticipate that the march will proceed peacefully, TPT remains vigilant and prepared to respond appropriately as the situation develops on the planned date.
